And I think this points to a, to a key problem within our judicial system. And that is that our law schools are not unlike any other school in our academic system that should be abolished. States. And so when they go into these courtrooms, they do not care about your sixth amendment rights or your fifth amendment rights because the federal rules of criminal procedure are what they follow. Not the sixth amendment that says that you have a right, to examine the nature and cause of the accusation and that you have a compulsory right to gather witnesses in your defense. But this is the red version, which is the symbol of the Communist Marxist, whatever it is you wanna say movement, right? So that's just the front cover. But if you turn to page nine before we get to that, this manual is put together by John Hopkins University Applied Physics Laboratory. And so when you talk about shadow governance, remember we have a Department of Defense and we have a state department, the Department of Defense is responsible for building the guerilla force and doing the things that are all part of the insurgency as part of unconventional warfare. It is the Department of State, Responsibility in this to build the incoming regime, right? That would be what is doctrinally referred to as a shadow government, right? So let me refer to you to another military document, right? And it is the United States Army Special Operation commands unconventional warfare, pocket guide. You can actually Google it, right? I bought or my girl, and bought me a actual hard copy of it. It's a little small, little man. It's only a few pages long, but it it's basically an unclassified summary of unconventional warfare. Now, I work as a non commissioned officer in charge of the highest level of classification policy oversight from conventional warfare. So I can assure you there is much, much more to

un, warfare and irregular warfare that is in this document. But all you need is this document because if you have the PDF version that you can find on Google, if you go to the actual numbered page nine or in the hard copy version I have, it's on page four. There is a pyramid diagram and it is titled Activities of an insurgency or resistance movement. Right. Now, there are 17 clandestine layers and then there are four overt layers and there's a line separating the two and that line covers shadow governance activities, right? And so as you work your way up the chart. If you start at the bottom and work your way up and just read every single line, you will be reading the 100 year, the last 100 years of American history and what we're in right now these last pages because we're in the shadow governance part. So we're actually straddling because see, this is the way it's supposed to work, right? A resistance movement basically results in open warfare, right? That's where the line is crossed over from clandestine to overt, right? Because the current regime wants to stay in power and they're going to try to crush the insurgency through counterinsurgency operations. And then the resistance is trying to, to overthrow the current regime. And so at some point, the resistance believe just like in star wars that they will be large enough to overthrow the empire. And that is when open warfare starts. The problem in the American situation is that they were so successful. There was never open fighting, and this can be pointed out by Yuri Beso, uh interview that he did in 1984 1985 where in 1985 Yuri Beso says that the communists have been so successful in demoralizing and executing what the Russians refer to as active measures, which is what I'm referring to as unconventional warfare based on us doctrine. And see when the American and I'm using air quotations when the American military is so weak because they've depleted all their arsenal, all their ammunition of what you hear stories about because we got to give it to Ukraine, give it to Ukraine, give it to Ukraine. See, once our military is depleted, well, that's when we have to make open calls for an international, peacekeeping force to come in and assist us in quelling all of these pesky resistance movements, right?
