So that was a big production that, uh, now has me the reputation of being famous amongst the, uh, the other inmates here. I, I, I'm in a new facility now. I don't know if you've heard, but they moved me to Citrus County Detention Facility, uh, which is about an hour and a half, two hours from where I was. Um, and it's a private run, uh, facility that's being run by law enforcement, which, uh, county Sheriff's office ran the previous, uh, facility. So I've only been here 14 days. And so nobody really knows much about me, but now a lot of the staff knows because it was like this big huge ordeal yesterday that the cameras and lights and everything set up in the courtroom, uh, for this face to face interview. And of course they had me handcuffed like I'm some kind of savage beast. But, um, but no, I mean, it's, uh, if we didn't adjust it to the new surroundings and uh learning who's who in the zoo here. Uh But uh we continue to speak out and uh do interviews. So I appreciate you giving me the opportunity to talk again today.

But because this place has a moderate, uh, I'm in a little bit higher of a security level, but I'm actually, I have my own room with a, like I'm in a room with a closed door. So living wise, uh, it, it, it seems to be better, but the way it works is, you know, that was a county jail that was authorized to hold federal inmates pending trial because I was sentenced. Then I was moved to this federal holding facility which normally acts as a transfer facility, kind of like a reception area or reception unit in the military, right? You go to the reception and then they divvy you out to whatever unit on base that you go to. Well, that's kind of how this normally works. But because I have a pending trial in DC, uh, we actually filed a motion to leave me here so that I'd have better access to my attorney. Um, and so that order was granted on Friday. So I will stay here until the trial date in DC is set. Uh, and then eventually they'll put me on some type of transportation with me up to DC for the trial. And then I'm sure they'll take as long as they possibly can to move me out of DC to an actual, the Bureau of Prisons facility. I see it until all of the truth comes out and then I am eventually freed. So

let's, so let's talk about what that's gonna look like for you, Jeremy because, you know, obviously we've seen, you know, Jake Chanley has, it looks like he's gotten a break, right? You know, he's in a

halfway house right now and the, the 14 hour 1000 hours of footage seems to have exonerated him. It was very clear the Capitol police were giving him a tour and escorting him around very peacefully. Well, because I've yet to go to a trial, uh, related to January 6th as they like to always proclaim, right? I mean, they, they claim that my trial in Tampa was just a simple search warrant case where I had illegal firearms and illegal explosives and classified materials. It had nothing to do with January 6th. That is until the, uh, P si the investigation by the probation office. Then it was all about January 6th. Right. So, um, what they're, what they're playing is a shell game with me and they're, they're kicking the can down the road. So they're very much stuck between a rock and a hard place with how to handle me. Now, they're very content. with getting all of these convictions and, and killing the story so that nobody hears about January 6th ever, ever again, except for on the anniversary kind of like 9 11. And so, and then once that is in place, then we'll, then we'll charge Jeremy Brown with all kinds of new charges to convict him basically out of the light where nobody will hear about them. But see, because of people like you and Laura Logan and Emerson and Jim and, and Dan Beatty and all of these other me, independent media voices that are out there exposing the truth on a daily basis. They're forced to, instead of letting the narrative die and be forgotten because of the X F L season is on now and it's the Stanley Cup playoffs.
